SALE OF REAL ESTATE USED BY BROWN COUNTY GENERAL HOSPITAL

The Board of County Commissioners of Brown County, Ohio, met on the 11th day of May, 2011, in regular session at the offices of said Board of Hospital Trustee's at the Brown County General Hospital in Georgetown, Ohio, with the following members present:

Ralph Jennings, President William R. Geschwind, Vice President Rick Eagan, Member

The following resolution was presented by Mr. Geschwind, who moved its adoption, and seconded by Mr. Jennings.

WHEREAS, the Board of County Commissioners was advised by Board of Trustees of Brown County General Hospital, ("Hospital Trustees") that the financial condition and operations of the Brown County General Hospital, d/b/a Brown County Regional HealthCARE, ("Hospital"), has deteriorated to the point where there is doubt as to the ability of the Hospital and continue as an ongoing concern; and

WHEREAS, the Board of County Commissioners finds the real estate used by the Hospital ("Real Estate"), as identified further described in Exhibit A, attached hereto and fully incorporated herein, is no longer needed for public use pursuant to R.C. §307.09; and

WHEREAS, after much consideration, the Board of County Commissioners, in conjunction with the Hospital Trustees had issued two Requests for Proposal for Acquisition of Assets and Operations ("RFP") of Hospital, pursuant to which it initiated a competitive bidding

process to enable the Real Property owned by Brown County, Ohio ("County") and used by the Hospital, identified and further described in Exhibit A, attached, and the assets and operations of the Hospital, to be sold, and/or otherwise disposed of, subject to the right of the Board of County Commissioners to reject any and all bids received; and

WHEREAS, the Board of County Commissioners and Hospital Trustees having previously received a number of proposals, including proposals from Essent Healthcare, Inc., and Falcon Investors, LLC, but was unable to negotiate final documentation or consummate a transaction with either of such entities; and

WHEREAS, on December 8th, 2010, the Board and Hospital Trustees subsequently issued an RFP to again solicit proposals for the acquisition of assets and operations of the Hospital, that best accommodated the three goals of the Board as set forth below:

- maintaining a full service acute care general hospital in Brown County to serve the residents of the community and surrounding areas;
- 2) maintaining jobs at the Brown County General Hospital to the extent consistent with the needs of the facility's operations; and
- using reasonable efforts to protect the General Fund of the County from exposure for Hospital obligations;

WHEREAS, in response to the December 8th, 2010 RFP, Southwest Healthcare Services, LLC, ("Southwest"), delivered a proposal dated January 6, 2011 ("Proposal"), for the acquisition of the assets and operations of the Hospital, including the Real Estate used by the Hospital. Said Proposal was the only response to the RFP.

WHEREAS, the Board of County Commissioners and Hospital Trustees has determined the Proposal best meets the requirements of the RFP and goals of the Board of County

Commissioners, and, on or about January 27th, 2011, executed a Letter of Intent with Southwest to negotiate an Asset Purchase Agreement ("APA");

WHEREAS, the Board of County Commissioners finds that Southwest has agreed to assume all liabilities of the Hospital, indemnify the Board of County Commissioners for any claims or losses, and will provide a secured promissory note in the amount of three hundred thousand dollars (\$300,000.00) for the funds owed by the Hospital to the County; and

WHEREAS, the Board of County Commissioners has retained and will reserve as an interest in the Real Estate, a perpetual Right of First Refusal;

WHEREAS, the Board of County Commissioners has concluded its due diligence duty and finds that Southwest is the highest responsible bidder pursuant to R.C. 307.10; and

WHERES, the parties have agreed upon a definitive APA, marked as Exhibit B, attached hereto and fully incorporated herein, that best meets the goals of the Board of County Commissioners and is consistent with its duties under the laws of Ohio; and

WHEREAS, the Hospital Board of Trustee's in its resolution of May 11th, 2011, has recommended to the Board of County Commissioners that the transaction with Southwest be concluded; and

WHEREAS, the Board of County Commissioners finds it in the best interest of Brown County to sell the Real Estate to Southwest; and

THEREFORE, BE IT RESOLVED, by the majority of the Board of County

Commissioners of Brown County, Ohio, that on the above findings, it hereby adopts, approves,
authorizes, and confirms, the sale of the Real Estate to Southwest, as such transaction is
described in the APA, and BE IT FURTHER RESOLVED the President of the Board of County

Commissioners is hereby appointed and authorized to execute and deliver at closing, any and all

documents to consummate the sales transaction with Southwest, including but not limited to the APA, Limited Warranty Deeds, and any and all security agreements or instruments.
