## Notice of Public Hearing Community Development Block Grant Funds Brown County, Ohio

Notice is hereby given that the Board of Brown County Commissioners will hold the 1<sup>st</sup> Public Hearing for Community Development Block Grant (CDBG) programming on March 2nd, 1:00 P.M. 2022 in the Brown County Commissioners Office, 800 Mt. Orab Pike, Georgetown, Ohio.

The Board of Commissioners is eligible to apply to the Ohio Department of Development for funding under the Community Development Block Grant (CDBG) Small Cities Program, and the Office of Community Development (OCD). The County is eligible to apply for Program Year 2022 CDBG funding, providing the County meets the applicable program requirements.

The purpose of the Public Hearing is to provide citizens in all jurisdictions (cities, villages, etc.) with information about the entire PY 22 Small Cities CDBG Program and PY 22 HOME Program and to permit discussion of possible applications to the Ohio Department of Development. A number of PY 22 CDBG and HOME programs may be available to the County including the Community Development Allocation Program, Critical Infrastructure, Residential Public Infrastructure, Community Housing Impact and Preservation (CHIP) Program, Economic Development Program, Neighborhood Revitalization Program, New Horizons Fair Housing Assistance Program, and Downtown Revitalization Program. The Community Development Allocation, CHIP, and Economic Development Programs will be discussed in detail.

In addition to an explanation of the Community Development Allocation, CHIP and Economic Development Programs, the Brown County Economic Development Revolving Loan Fund (RLF) will also be reviewed. The CDBG financed RLF will permit the County to provide loans and grants at the County's discretion for the purposes of economic development.

The Public Hearing will cover eligible activities, program requirements, funding allocations, and related matters. The CDBG and HOME programs can fund a broad range of activities, including, but not limited to, economic development projects; street, water supply, drainage and sanitary sewer improvements; demolition of unsafe structures; and rehabilitation of housing and neighborhood facilities. The activities must be designed to primarily benefit low-to-moderate income persons, aid in the preservation or elimination of slum and blight, or meet an urgent need of the community.

The following CDBG programs are available to Brown County. All funding levels are approximated due to the commencement of Brown County's 1<sup>st</sup> 2022 CDBG Public Hearing prior to the release of program funding cap information for the PY 22 year from the Ohio Department of Development:

- 1. Community Development Allocation Program \$150,000.00 -minimum award
- 2. Community Housing Impact and Preservation Program \$400,000.00
- 3. Residential Public Infrastructure Program \$750,000.00
- 4. Critical Infrastructure Program \$500,000.00
- 5. Neighborhood Revitalization Program \$750,000.00
- 6. Target of Opportunity Program \$Funding Level negotiated
  - a. Downtown Buildings -\$250,000
- 7. Economic Development Public Infrastructure Program \$500,000.00
- 8. Economic Development Loan Program--\$500,000.00

## 9. New Horizons Fair Housing Assistance Program - \$15,000.00

A second Public Hearing will be held to discuss a specific application for a specific program mentioned above in the event application is made by the Brown County Board of Commissioners to the Ohio Department of Development under a particular program. A PY 22 Community Housing Impact & Preservation Program Application will be submitted to the Ohio Department of Development on or before the May 2022 deadline thus a second public hearing is planned for April 20th, at 1:00 P.M., to review the County's proposed activities.

Both Public Hearings are open to all residents of Brown County and any persons or organizations desiring to speak on the matter will be afforded an opportunity to be heard or seen. Citizens from all jurisdictions (cities, villages, townships etc.) are encouraged to attend this first Public Hearing on March 2<sup>nd</sup>, 2022 at 1:00 P.M., to provide their input on the County's entire CDBG/HOME Program. In compliance with the Americans with Disabilities Act, individuals needing special accommodations (including auxiliary communicative aids and services) during these hearings should notify Kelly Cole at 800 Mt.
