WHEREAS, the Brown County Board of Commissioners finds the area known as the female block of the Brown County Detention Center, known as 755 Mount Orab Pike, Georgetown Ohio 45121 contains 6 jail cells, and houses approximately 12 inmates;

WHEREAS, the Brown County Board of Commissioners finds they cannot continue to house all female inmates in Butler County Jail as they have done for the last 15 months due to overcrowding at the Brown County Detention Center because of the cost incurred;
