National Public Safety Telecommunicators Week

April 11 to April 17, 2021

Whereas emergencies can occur at any time that require police, fire or emergency medical services; and,
Whereas when an emergency occurs the prompt response of police officers, firefighters and paramedics is critical to the protection of life and preservation of property; and,
Whereas the safety of our police officers and firefighters is dependent upon the quality and accuracy of information obtained from citizens who telephone the Brown County Communications Center; and,
Whereas Public Safety Telecommunicators are the first and most critical contact our citizens have with emergency services; and,
Whereas Public Safety Telecommunicators are the single vital link for our police officers and firefighters by monitoring their activities by radio, providing them information and insuring their safety; and,
Whereas Public Safety Telecommunicators of the Brown County Communications Center have contributed substantially to the apprehension of criminals, suppression of fires and treatment of patients; and,
Whereas each dispatcher has exhibited compassion, understanding and professionalism during the performance of their job in the past year;
Therefore, Be It Resolved that the Board of County Commissioners of Brown County Ohio declares the week of April 11 through 17, 2021 to be National Public Safety Telecommunicators Week in Brown County, in honor of the men and women whose diligence and professionalism keep our county and citizens safe.
