# RESOLUTION FOR PLACEMENT OF A LEVY IN SUPPORT OF BROWN COUNTY OSU EXTENSION

The Board of Commissioners, Brown County, Ohio, met in regular session on the 3rd day of December, 2019, at the office of said Board, with the following members Present:

Mr. Woodruff, moved the adoption of the following resolution:

## A RESOLUTION DECLARING IT A NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Ohio State University Extension Programs for Brown County, Ohio, therefore be it

SECTION 1. The Board of Commissioners of Brown County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten-mill limitation for the benefit of providing revenue to Brown County, Ohio through the OSU Extension for 4-H Youth Development, Agricultural and Natural Resources, Family & Consumer Sciences, and County Development per Ohio Revised Code Section 5705.19(WW) at a rate not exceeding twenty five hundredths (0.25) mills for each one dollar (\$1.00) of valuation, for a new tax of twenty five hundredths (0.25) mills for five (5) years commencing tax year 2020, collectable in 2021.

SECTION 2. That the question of levying additional taxes be submitted to the electors of said Brown County at the Primary Election to be held at the usual voting places within said Brown County on the 17<sup>th</sup> of March, 2020.

SECTION 3. That said levy shall be extended on the next annual tax list of Brown County OSU Extension Office for the current year if more than fifty percent (50%) of the electors voting thereon vote in favor thereof, and be it further

SECTION 4. The form of the ballot for said tax levy shall be substantially as follows:

PROPOSED TAX LEVY BROWN COUNTY A majority affirmative vote Is necessary for passage

An additional tax for the benefit of providing revenue to Brown County, Ohio through the OSU Extension for 4-H Youth Development, Agricultural and Natural Resources, Family & Consumer Sciences and County Development at a rate not exceeding twenty five hundredths (0.25) mills for each one dollar (\$1.00) of valuation, which amounts to \$0.025 for each one hundred dollars of valuation, for five (5) years, commencing in 2020, first due in calendar year 2021.

That the Clerk of this Board of Commissioners be and is hereby directed to certify a copy of this Resolution to the Board of Elections, Brown County, Ohio 90 days prior to election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted at an open meeting of this Board and that all deliberations of this Board or any of its committees that resulted in such formal action were in meetings open to the public and comply with all legal requirements, including Section 121.22 of the Ohio Revised Code.
