A Resolution for the continuation of the existing levy of the additional sales tax pursuant to R.C. 5739.026(A)(6) for the implementation and operation of the County 911 Emergency System.

WHEREAS, the Brown County Board of County Commissioners, having determined the county's present tax revenues are insufficient to insure the proper fiscal implementation and operation of the County 911 Emergency System; and

WHEREAS, R.C. 5739.026(A)(6) permits the Board of County Commissioners to levy a tax of up to one-half of one percent upon every retail sale within the county, except sales of watercraft, outboard motors required to be titled pursuant to Chapter 1548 of the Ohio Revised Code, and sales of motor vehicles, to pay the expenses of the administration of the tax and to provide revenue for the implementation and operation of a County 911 Emergency System.

WHEREAS, the Brown County Board of Commissioners finds that the continuation of the original levy of a sales tax, pursuant to R.C. 5739.026(A)(6) will expire after the 2013 tax year, and that it is necessary to levy the sales tax of one-fourth of one percent for an additional five year period, for the purposes of the implementation and operation of the County 911 Emergency System.

BE IT HEREBY RESOLVED by the Brown County Board of Commissioners, with at least two-thirds of its members concurring, that it is necessary to levy a sales tax of one-fourth of one percent on all retail sales and corresponding use tax, upon those transactions, uses, or other consumption as defined in R.C. 5939.026(A) and 5741.023, for the benefit of Brown County, Ohio, and for the purposes of implementing and operating a 911 Emergency System within Brown County, Ohio pursuant to R.C. 5939.026(A) and 5741.023, beginning and covering the following tax years: 2014, 2015, 2016, 2017, and 2018, which levy shall be a continuation of the existing sales tax of one-

fourth of one percent for the implementing and operation of the County 911 Emergency System.

BE IT THEREFORE RESOLVED that the Clerk of the Board of Commissioners certify a copy of this resolution to the Board of Elections for Brown County, Ohio prior to the time required by law and notify the said Board of Elections to cause notice of election of the question of the levying of said sales tax to be given according to law and place the question of said tax levy on the November 6, 2012 general election ballot, pursuant to law.

RE: RESOLUTION TO CLOSE ROADS IN HUNTINGTON TOWNSHIP

After reviewing the roads listed in the resolution, the Brown County Engineer's Office has prepared the following report in accordance with the Ohio Revised Code, Chapter 5553.045. Included in this report is a brief description of each road and surrounding properties along with a suggested legal description or other recommendations.

T-235 Hickory Ridge Road:

After review of the portion of Hickory Ridge Road included in the township's resolution, I see no problems with the closing of this portion with some corrections to the description. According to information that we have on file the portion of the road that is open and not on non-maintained status, described as beginning at State Route 763 and extending in a westerly direction 5990 feet, does not reach the property corner of Perin Farms and Richard Shelton.

Therefore, I suggest the following description for the closure.

T-235 Hickory Ridge Road Description

All of T-235 Hickory Ridge Road, **SAVE AND EXCEPT** that part beginning at the intersection of State Route 763 extending in a westerly direction approximately 8190 feet to a point in the centerline of Hickory Ridge Road, said point being a northeast corner of the 46.08 acre tract conveyed to Richard E. Shelton, O.R. 259, Page 2186. Said point also being a southeast corner of the 64.335 acre tract conveyed to Perin Farms, O.R. 19, Page 766.

T-237 Wiles Road:

After review of the portion of Wiles Road included in the township's resolution, I see no problems with the closing of this portion. There is only approximately 293 feet of Wiles Road in Huntington Township, all of which lies within Perin Farms.

Therefore, I suggest the following description for the closure.

T-237 Wiles Road Description

All of T-237 Wiles Road that lies within Huntington Township, approximately 293 feet.

T-237 Upper Eagle Creek Road:

After review of the portion of Upper Eagle Creek Road included in the township's resolution, I see no problems with the closing of this portion. There is approximately 2760 feet of Upper Eagle Creek Road in Huntington Township, all of which lies within Perin Farms. **Therefore**, I suggest the following description for the closure.

T-237 Upper Eagle Creek Road Description

All of T-237 Upper Eagle Creek Road that lies within Huntington Township, approximately 2760 feet.
