- 4. The fees shall only apply to work at the trial court level and the Board of Commissioners reserves the right to retain a different counsel for Dr. Varnau in the event an appeal is pursued, and determine whether the Board of Commissioners shall be obligated to pay counsel fees on an appeal;
- 5. The total fees shall be capped at \$10,000.00 with the express understanding that Dr. Varnau and her counsel can request an increase of the \$10,000.00 amount if necessary;
- 6. The Board of Commissioners shall retain the right to seek recovery from Dr. Varnau personally of all counsel fees it expends on her behalf in the event that she is removed from office as a result of a final order of court finding any grounds for removal established under R.C. 3.07.
