The undersigned being all of the owners of the real estate in the unincorporated territory of a township hereby requests the annexation of that territory to the Village of Mt. Orab, Brown County, Ohio pursuant to Ohio Revised Code Section 709.02, 709.021, and 709.023.

- A. There are three owners of the real estate in the territory proposed for annexation. They are Ronald D. Keller, an unmarried person, Michael A. Keller and Jodi J. Keller, husband and wife. 'All three have signed the petition below and have dated their signature.
- B. A full and accurate legal description of the perimeter of the territory proposed for annexation is attached hereto and incorporated herein by reference. 
