Commissioner Barry Woodruff participated in a CCAO Committee Conference call regarding Jobs, Economic Development and Infrastructure.




Motion moved by Mr. Applegate to adjourn this meeting with no further business before the Board this day April 23, 2014. Second: Mr. Gray.


