The following resolution was presented by Mr. Ellis, who moved its adoption, and seconded by

Mr. Woodruff.

WHEREAS, Brown County started accepting credit card and debit card payments for expenses due the county through financial transaction devices in 2016;

WHEREAS, the Board finds it would continue to be in the best interest of the County, and further, will continue to increase convenience to the public, if the County continues to approve the use of financial transaction devices;

WHEREAS, R.C. §301.28(B) authorizes the County to accept payments by financial transaction devices for expenses due to the county;

WHEREAS, the Brown County Recorder and Probate Juvenile Court have approached the board to request the county seek proposals for a new third-party vendor;

THEREFORE BE IT RESOLVED:

In accordance with R.C. 301.28(B) the Board authorizes the acceptance of payments by financial transaction devices for expenses due to the county;

BE IT FURTHER RESOLVED:

- (1) The Board further specifies those county officials and county offices that are authorized to accept payments by financial transaction devices:
 County Auditor, County Treasurer, County Recorder, Prosecuting Attorney, Sheriff,
 Clerk of Probate Court, Clerk of Juvenile Court, Clerk of Court for all Common Pleas
 Divisions, Clerk of County Operated Municipal Court, Clerk of Court for Common
 Pleas, Clerk of County Court, Board of Health, Board of Commissioners/Building
 Department.
- (2) The Board further specifies what expenses may be paid for through the use of financial transaction devices:
 Fees, costs, taxes, assessments, fines, penalties, payments or any other expense a
 person owes or otherwise pays to a county office under the authority of a county
 official, other than dog registration and kennel fees required to be paid under Chapter
- (3) The Board further specifies the identification of financial transaction devices that are authorized as acceptable means of payment received for expenses due to Brown County:

Major bank credit card

955 of the Revised Code.

- (4) The Board further specifies and authorizes a surcharge or convenience fee accessed to the person using the financial transaction device, to be set at the amount equal to the transaction or other costs accessed to the County by the respective financial institutions or the issuers or processers of the transactions;
- (5) The Board further specifies and authorizes a penalty accessed to the person using the financial transaction device if the payment made by the means of the financial transaction device is returned or dishonored for any reason, set in the amount necessary to reimburse the County for banking charges, legal fees, or other expenses incurred by the County in collecting the returned or dishonored payment;

BE IT FURTHER RESOLVED:

In accordance with R.C. 301.28, the Board designates the County Treasurer as the administrative agent to solicit proposals from financial institutions, issuers of financial transaction devices, and processors of financial transaction devices, to make recommendations about the proposals, and to assist the county offices in implementing and supervising the County's financial transaction devices program;

The Commissioner's Clerk shall send a copy of this resolution to all county officials

authorized to accept payments by financial transaction devices;
