WHEREAS, some people are at higher risk of developing sepsis, including infants, the elderly, those with chronic illnesses, and those the weakened or impaired immune systems; and

WHEREAS, with more than 350,000 lives lost to the condition per year, sepsis ranks as the third-leading cause of death in the United States, and with more than 1.7 million cases of sepsis every year, survivors often face long-term effects, including amputations, anxiety, memory loss, chronic pain and fatigue, and more; and

WHEREAS, Only 66% of American adults have ever heard the word sepsis. With more than 350,000 lives lost per year, sepsis ranks as the third leading cause of death in the U.S. There are more than 1.7 million cases of sepsis every year and survivors often face long-term effects post-sepsis, including amputations, anxiety, memory loss, chronic pain and fatigue, and more; and

WHEREAS, sepsis can be remembered with the mnemonic "TIME", which stands for Temperature, Infection, Mental decline, and Extremely ill; and

WHEREAS, to avoid sepsis, people should take good care of chronic conditions, get recommended vaccines, and practice good hygiene, especially when treating wounds; and

WHEREAS, awareness of the signs and symptoms of sepsis along with rapid diagnosis and treatment can save lives and improve outcomes for sepsis survivors; and
