WHEREAS, the Brown County Board of Commissioners recognizes the need to support political subdivisions across Brown County in delivering critical infrastructure and capital improvement projects;

WHEREAS, the Board finds that communities within Brown County often face funding gaps or lack access to flexible financing options necessary to advance infrastructure, economic development, and community asset projects;

WHEREAS, the Board further finds it has the authority under O.R.C. § 307.07 to make loans and provide financial assistance for the purpose of economic development, including financial assistance for permanent public improvements;

WHEREAS, the Board desires to strengthen local government capacity by providing low-interest loans that support responsible project development and encourage economic growth;

WHEREAS, the Board finds that establishing a dedicated county fund will streamline the ability of townships, villages, municipalities, and other political subdivisions to move critical projects forward, improve quality of life, and foster county-wide economic resilience;

THEREFORE, BE IT RESOLVED by the Board of Commissioners of Brown County, Ohio, that the Build Brown County Fund is hereby established for the purpose of providing low-interest loans to political subdivisions for infrastructure, capital improvements, and time-sensitive projects;

BE IT FURTHER RESOLVED that the Build Brown County Fund shall be administered through the Brown County Department of Economic and Community Development, which shall develop guidelines, application procedures, and review criteria for project funding, subject to approval by the Board;

BE IT FURTHER RESOLVED that any awards made through this fund shall require Board approval.

WHEREAS, the Brown County Board of Commissioners previously established the Build Brown County Fund for the purpose of providing low-interest loans to political subdivisions for infrastructure, capital improvements, and time-sensitive projects;

WHEREAS, the Board finds it necessary to establish an annual interest rate for all loans issued through the Build Brown County Fund to ensure consistency, transparency, and responsible financial administration:

WHEREAS, the Board further finds that setting the interest rate at a predictable and uniform level provides stability for political subdivisions while protecting the fiscal integrity of the fund;

WHEREAS, the Board has reviewed current financial conditions and finds that an interest rate of 3.5% is reasonable, fair, and consistent with the purpose and objectives of the Build Brown County Fund;

THEREFORE, BE IT RESOLVED by the Board of Commissioners of Brown County, Ohio, that the interest rate for all loans issued under the Build Brown County Fund during calendar year 2025 shall be set at 3.5%;

BE IT FURTHER RESOLVED that this rate shall apply to all loan agreements executed between November 24, 2025, and December 31, 2025, unless otherwise directed by subsequent Board action.
