WHEREAS, the Board has previously met in open meeting and adopted an Operating Agreement with the Brown County Humane Society to operate the Animal Shelter;

WHEREAS, the Brown County Humane Society met with the Board of Commissioners in spring and fall of 2024 to request additional funding to continue their duties pursuant to the Operating Agreement;

WHEREAS, the Board finds they have the authority to make a yearly contribution to the Humane Society for the operation of the Animal Shelter;

WHEREAS, the Board finds it would be difficult for the Humane Society to continue the performance of the agreement after reviewing the revenue and expenses over the last fiscal year;

WHEREAS, the Board finds the county would benefit for the Humane Society to continue in its performance of its duties under the Operating Agreement;

THEREFORE, BE IT RESOLVED, by the majority of the Board of Commissioners of Brown County, Ohio, that on the above findings, it hereby adopts, approves, authorizes, and confirms, the Sixth Addendum to the Operating Agreement with the Brown County Humane

The Board of County Commissioners of Brown County, Ohio, met in regular session on the 12th of January, 2026.

Commissioner Ellis moved the adoption of the following

**RESOLUTION**

**WHEREAS**, the Board of County Commissioners has decided that the health, welfare and safety of the people of Brown County can best and most efficiently be served by the "Force Account" in matters pertaining to maintenance, repair, construction, and reconstruction of Brown County roads, bridges, culverts etc.

**THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners, Brown County, Ohio, does hereby authorize Todd Cluxton, Brown County Engineer to use the existing county employee forces and proceed by "Force Account", as outlined in Section 5543.19 of the Ohio Revised Code, in the maintenance, repairs, construction of roads, bridges, and culverts in Brown County during the year 2026; and,

**January 12, 2026**

BE IT FURTHER RESOLVED, that the Board of County Commissioners, Brown County, Ohio, does hereby authorize Todd Cluxton, Brown County Engineer to purchase all such materials, supplies, repair parts, tools, equipment, fuels, oils, etc., required to proceed with the force account in the year 2026, when the cost is less than two hundred and forty four thousand, six hundred and fifty dollars (\$244,650), and when he is permitted by law to undertake such construction, reconstruction, improvement, maintenance, or repair of roads, bridges, culverts etc., by force account.

WHEREAS, the Ohio Revised Code Section 153.64, 4931 and 4933, provides to the Board of County Commissioners, the authority to control the installation and placement of any public utilities within the dedicated public right-of-ways of all County maintained highways; and,

WHEREAS, the Ohio Revised Code Section 5589 and 5543 provides to the Board of County Commissioners, the authority to control any digging and excavating on or along a County maintained highway and for the placement of a private driveway approach to a County maintained highway; and,

THEREFORE, BE IT RESOLVED that the Board of Brown County Commissioners does hereby authorize the Brown County Engineer to develop and administer permits for the above described activities within County road right-of-ways and to keep said permits with the permanent road records of Brown County; and,


