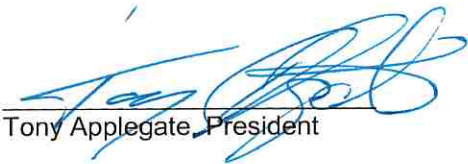

Commissioner Gordon Ellis attended the BET LEPC meeting.

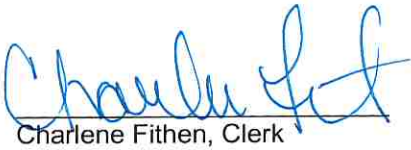
